On January 23rd, during our Plan of the year, your Norfolk Jaycees 2010 Board of Directors developed a proposal for your consideration. This proposal will affect the current Norfolk Jaycees Handbook & By-Laws. (See reverse side for specifics.)

Currently we have three meetings a month – two Membership/Business meetings (2nd & 4th Tuesday) and a Board meeting (1st Monday). We are proposing a change to two meetings per month - one Membership/Business meeting per month (2nd Tuesday) and one Board meeting per month (4th Tuesday). This will not affect the various socials, monthly outings, or the community service events, nor will it impact the weekly reminder emails to communicate upcoming events.

We all lead very busy lives and understand it's hard to come out to a Jaycee event after a long day at work or after a late night of socializing. This year we do not have a President and have only four dedicated Board Members. It can be difficult to plan out an exciting year without a full Board and without Membership involvement. There has been a lack of participation at events and membership meetings. The Chapter needs your help to survive...we need you to get more involved!

Current Handbook Description –

Membership Meetings

The Norfolk Jaycees hold two membership meetings each month. These meetings are on the second and fourth Tuesday of each month at 7:00 p.m. Meetings are held at the Fred Heutte Center at 1000 Botetourt Gardens in the Ghent area of Norfolk.

[Proposed: The Norfolk Jaycees will hold at least one membership meeting each month. For 2010, the meeting is scheduled on the second Tuesday of each month at 7:00 p.m. Meetings are held at the Fred Heutte Center in Ghent - 1000 Botetourt Gardens, Norfolk, VA 23507, unless otherwise indicated.]

Meetings cover chapter business and upcoming events, projects and socials, as well as workshops for training and guest speakers. Guest speakers are invited to cover topics such as stress management, taxes, management skills and much more. Members are always encouraged to invite guests to any meeting or event and to submit ideas for future speakers, topics or projects.

Current By-Laws –

3.01 Regular Membership Meetings

Regular membership meetings shall be held semi-monthly at such time and place as may be designated by the President or Board of Directors.

General membership meetings shall be held at least once a month at such time and place as may be designated by the President or Board of Directors.]

3.03 Regular Board Meetings

The Board of Directors shall meet at least once each month at such times and places as may be designated by the president or Board of Directors.

4.01 Annual Election

The annual election of the officers and directors shall be held at the second regular membership meeting in October. The installation of officers and directors shall be held at a time and place selected by the Board of Directors, and the new officers and directors shall assume their duties on the first day of December.

The annual election of the officers and directors shall be held at the regular membership meeting in November. The installation of officers and directors shall be held at a time and place selected by the Board of Directors, and the new officers and directors shall assume their duties on the first day of December.]

8.02 Amendments

These by-laws may be amended by two-thirds vote of the members present at any regular membership meeting provided that at least fourteen (14) days prior written notice of the proposed action has been given to all members in good standing.
